Application Submittal requirements:

1. Application is limited to 10 pages maximum excluding all exhibits and attachments.
2. The Application must contain the cover sheet provided above as the first page.
3. Describe in detail (500 words maximum) why this Nomination merits outstanding recognition from CARPD.
 - What is the nature of the contribution. Be specific; give detail and dates.
 - How has Nomination advanced the concept of Recreation and Parks.
 - How has this contribution benefited the community.
 - Give reasons why Nomination should be selected for this award.
4. Provide a 50 to 100 word summary of the highlights of this nomination (bullet lists are suggested) for possible use in a PowerPoint presentation.
5. Awards presentation is a Power Point Format, hard copy along with disk or CD must accompany submittal. Include the following in electronic format:
 - Full copy of the application.
 - District Logo.
 - Photographs of the Nominee, Group, Project or Facility.

Submit four copies plus one electronic copy (CD) to be reviewed by the Awards Committee. If less than four (4) copies and an electronic copy (CD) are received, the entry will not be considered.

Entries post marked after March 14, 2009 will not be considered.

More than one award may be made in any category, if so determined by the Awards Committee. Likewise, the Awards Committee may not make any awards in any category.

All applicants will receive a notification, announcing the decisions of the Awards Committee.

All award winners will be announced at the annual CARPD Conference Awards Banquet (Saturday April 25, 2009); award recipients are encouraged to attend.
